## **Scottish Government launches Health and Wealth In Scotland: A Statement of Intent for Innovation in Health**

Nicola Sturgeon MSP has launched the Scottish Government's position on embedding innovation in NHS Scotland. It aims to increase partnership working so that NHS Scotland can develop its use of new innovative technology to improve the quality of care which patients receive and enable more people to be cared for at home. It commits to set up Health Innovation Partnerships between life sciences businesses and the NHS in Scotland, and to have them up and running by the beginning of 2013. *For more information [Click here](#)*
